254/24 There were no declarations.

MINUTES OF MEETING ON 7 NOVEMBER 2024

MINUTES OF LEGAL COMMITTEE

PARLIAMENT PIECE

260/24 The trustees ratified their unanimous decision made by email on 5 December 2024 to approve expenditure of an additional £750 to replace a gate at Parliament Piece with a Radar, wheelchair-accessible kissing-gate.

DELEGATED EXPENDITURE

261/24 It was noted that the general secretary had approved expenditure of up to £2,000 for counsel's opinion on case 24-12.

DELEGATED AUTHORITY TO INCREASE EXPENDITURE ON A SUM ALREADY APPROVED BY TRUSTEES

The recent need for OSS to seek a whole-board decision for a minor cost adjustment highlights the need for greater flexibility in certain circumstances. It was agreed that, when unforeseeable events occur, the GPC could determine whether whole board involvement is warranted. Phil Wadey agreed to suggest an amendment to the terms of reference of the general purposes committee accordingly, for the trustees to consider at the next meeting.

FINANCIAL MATTERS

Minutes of finance committee on 19 November 2024

263/24 The trustees noted the minutes.

Financial policies and procedures

Following some correspondence between trustees on the financial policies and procedures, the trustees considered that more work was needed to clarify them, with definitions of terms used. Trustees were asked to send any comments by 20 December, and Phil Wadey agreed to produce a further version for consideration by the finance committee and then trustees.

Draft budget for 2025

After discussion, the trustees unanimously approved the draft budget, and increment for staff salaries, as recommended by the finance committee.

RISK REGISTER

- 266/24 The trustees noted the additions to the risk register following the last meeting:
 - (a) A4: A risk of not being able to attract new trustees to give a more diverse balance to the board. It was agreed to refer this to the equality, diversity, and inclusion working party to consider the controls and further action.
 - (b) B8: Having the right amount of cash available to meet our needs. This item was approved.
